**DECISION:**

Mst. Atiya Amjad wife of Amjad Ali resident of House No. 36-G, CAA Colony, Waltan Airport Lahore, bearing CNIC No. 38403-5674491-4 complainant has approached this office by moving a complaint, contending therein, that her father has died and left behind a house situated at House No. L-10, Street No. 4, Quaid e Azam Colony, Dhamyal Road, Rawalpindi in his inheritance. Complainant is also sharer in the above said house as a daughter but it is in the possession of respondents namely Abid Imam & Farhat Jabeen (wife of late Farooq Arjmand).

Complaint was maintainable in the light of preliminary assessment of produced record of said property heaving Khewat / Khotoni No. 534/730 Khsra No. 1206.

Respondents Mr. Abid Imam S/o Wazir-Ud-Din resident of House No. 10-L, Street No. 04 Quaid-e-Azam Colony, Dhamyal Road, Rawalpindi and

Mst. Farhat Jabeen widow of Farooq Arjumend resident of House No. 10-L, Street No. 04 Quaid-e-Azam Colony, Dhanyal Road, Rawalpindi were summoned, only Mr. Abid Imam in person appeared and stated that the said property is only in the possession of Mst. Farhat Jabeen and submitted his affidavit contending therein that he is agree and willing to give the actual share of the complainant without any objection according to law. Mst. Farhat Jabeen and all other legal heirs were also summoned, Mst. Farhat Jabeen appeared in person and submitted a statement contending therein that:

**She was came in said property (house) after marriage in October, 1981 and living there since last 41 years. She further stated that:-**

- 1. At that time her father-in-law have not any source of income and her husband was working out of country and send money for construction of said property and constructed double story house.**
- 2. First flour was under her possession for living purpose then her husband Mr. Farooq Arjumend died in 2001 and with the consent of her mother-in-law first flour was remain in her possession with her children after that she renovated her living area.**
- 3. Her children and she has not owned any property and said property (house) is only source of living for her and her children.**

4. Her father-in-law had died in 1987. She was not aware about declaration of inheritance regarding said property before 17 years as per complaint.

5. She is 60 years old age lady and suffering with diabetes since 20 years so transfer her case to Rawalpindi office of Ombudsperson to resolve this matter.

She is law abiding and willing to give the actual share to all legal heirs, *without any objection according to law.*

Mr. Nasir Mehmood S/o Wazir-Ud-Din resident of House No. 370, Street No. 34, Sector-I Ghulsan Abad Adyala Road, Rawalpindi, Ms. Nasra Aliya wife of Muhammad Zubair Naseem resident of House No. 11-L, Lane No. 04 Quaid-e-Azam Colony, Dhamyal Road, Rawalpindi and Mr. Faraz Akhtar S/o Wazir-Ud-Din resident of House No. 370, Street No. 34, Sector-I Ghulsan Abad Adyala Road, Rawalpindi appeared and submitted there affidavits separately contending therein that they are agree and willing to give the actual share of the complainant without any objection according to law before the undersigned and all were heard at length.

It was agreed upon by all concerned that they are willing to give the share of the complainant according to sharia and record. All have put their signatures and thumb marks.

In view of all this complaint is allowed and respondent was directed to give the possession/share to the extent of complainant till next date of hearing, failing which order will be executed in accordance with law. Later on it was



informed to this office by the complainant that she has received rupees Ten lac (1,000,000) as a compensation from respondents and she is satisfied. Parties have put their signatures and thumb mark as a token of proof. File be consigned to record room.
