In the light of Section 5 (2) of the Act, Delivery of possession and transfer of ownership of property to women - *The Ombudsperson may, where deemed fit, direct the officer in charge of Police Station for such assistance as may be required for the purposes of implementing the orders passed under subsection (1).*
